MUNICIPAL ORDINANCE # 003-009  
Series of 2009

**AN ORDINANCE** AMENDING SECTION 64 (PAR. 1 & 2), SECTION 69, AND SECTION 72 OF MUNICIPAL ORDINANCE 012-008 SERIES OF 2008, OTHERWISE KNOWN AS THE REVISED TRANSPORT AND TRAFFIC CODE OF CAMALIGAN, CAMARINES SUR

**WHEREAS**, Municipal Ordinance 012-008 is enacted to manage, regulate, and control the entire land transport system within the jurisdiction of the municipality;

**WHEREAS**, there is a need to amend certain provisions of the said ordinance to meet the demands of the present situation of the public transport system, most particularly:-

- (1) The changing of name from STPODA to SMSTPODA as requested by the group itself with members being composed of residents of the said barangays and their pick-up station situated at their boundaries;
- (2) Free Zones shall be exclusive for SMSTPODA, PPODA, and SJSRPODA;
- (3) Adjustment of number of trimobile units for Dugcal-Sua route, and padjak units for selected padjak groups;
- (4) Provisions for registration of private trimobiles;

**WHEREAS**, it is the policy of the local government to oversee the operation of the entire public transport system, ensuring order and maintaining balance between the supply and demand for this kind of transport service;

**WHEREFORE**, on motion by Councilor Diano SJ. Ibardaloza, Jr., duly seconded by all the members present,

**BE IT ORDAINED** by the Sangguniang Bayan of Camaligan, Camarines Sur that:-

**SECTION 1.** Municipal Ordinance # 012-008, Section 64 (paragraph 1) is hereby amended changing the name of STPODA to SMSTPODA clarifying the area of operation for SJSRPODA and STPODA and; increasing the number of units for MAPODA and DSPODA-Pedaled. Section 64 (par. 1) now reads as follows:-

**SECTION 64 – Limitation and Area of Operation.** Every pedaled/motorized padjak intended “For Hire” operation shall, prior to registration, apply for membership at accredited padjak association, governed by the following conditions.

- 1.) Each association shall have a limited number of members which shall be restricted to ply on specific routes hereunder stipulated:-

**SECTION 2.** Municipal Ordinance # 012-008, Section 64 (paragraph 2) is hereby amended clarifying the padjak groups who may operate at free zones and; the time for free zone at school area. Section 64 (par. 2) now reads as follows:-

- 2.) The following areas will be considered FREE ZONES, wherein, SMSTPODA, SJSRPODA and PPODA members may be allowed to operate randomly at herein specified day and time:

Church	Sundays and Special occasions
Municipal Hall & Plaza	During every scheduled occasion/event at the plaza & emergency

**SECTION 3.** Section 69 is hereby amended to include fees for the registration of private trimobiles, which shall now read as follows:-

**SECTION 69 – Registration.** All trimobiles not intended for public conveyance, are required to secure a registration permit from the Municipal Government not later than the 31<sup>st</sup> of January every year. Hereunder are the prescribed fees:-

Private Trimobiles has to undergo inspection by the Trimobile Task Force upon application for registration and the owner shall be required to furnish the following:-

- 1) Appropriate proof of not less than one (1) year continuous residence in the municipality at the time of filing of application which includes:-
  - i.A certificate as to the applicant’s continuous residence containing the applicant’s full name, exact address, number of months of actual residence, age, citizenship, and the purpose of certification, issued by the Barangay Captain of the applicant’s present residence. If the

- applicant has less than one (1) year stay in his present residence, but previously resided in another barangay or barangays within the municipality, the applicant shall secure a certification from the Barangay Captains of his previous residences until the minimum one (1) year requirement is met;
- ii. In case of juridical persons, their Mayor's Permit, Business tax Receipt, and Community Tax.
- 2) Proof of ownership of tricycle unit(s) as contained in the application which is the registration certificate issued by the Land Transportation Office (LTO);
  - 3) LTO Certificate of Registration with OR and Certification as to the safety and roadworthiness of the applicant's tricycle unit(s) for which he is applying a franchise to operate in consonance with Certificate on Road Worthiness by PNP and LTO;
  - 4) Third Party Liability Insurance Coverage.

**SECTION 4.** Section 72 of Municipal Ordinance # 012-008 is hereby amended to increase the number of units allowed to operate in this route, which will now read as follows:-

**SECTION 72 – Limitation and Area of Operation.** The number of trimobles operating in the Dugcal-Sua route is hereby pegged at forty one (41) units.

Each qualified applicant, whether single proprietor, partnership, or corporation, shall be limited to a maximum of two (2) units of public utility trimobles only;

Operation of Dugcal-Sua trimobles shall be limited at Barangays Dugcal and Sua area only. They shall be allowed to enter the free zone and other areas declared under section 63 of this code only during the same conditions stated thereat. All other areas not explicit mentioned shall be prohibited for their operation.

**SECTION 5. Repealing Clause.** All ordinances, rules, orders, and regulations or parts thereof contrary to or inconsistent with any of the provisions of this code are hereby repealed;

**SECTION 6. Separability Clause.** If any provision of this code, or the application thereon to any person or circumstances is held invalid, the remainder of the code, and the application of such provision, and the application to other persons or circumstances shall not be affected thereby;

**SECTION 7. Effectivity.** This ordinance shall take effect in full and immediately upon its approval, unless otherwise suspended by the proper authorities.
