### MUNICIPAL ORDINANCE # 06

Series of 2011

**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE # 012-08, OTHERWISE KNOWN AS THE 2008 REVISED TRANSPORT AND TRAFFIC CODE OF THE MUNICIPALITY OF CAMALIGAN, CAMARINES SUR PARTICULARLY ARTICLE II SECTION 8 AND ARTICLE V SECTION 24 THEREOF, PERTAINING TO NO-PARKING AREAS AND DEPUTIZED TRAFFIC ENFORCERS, RESPECTIVELY.**

**WHEREAS**, periodic review of existing ordinances by the local legislative body is proper and necessary to answer to the call of the times;

**WHEREAS**, the transport and traffic rules of the municipality is one set of rules which need to be reviewed;

**WHEREAS**, the area between the Camaligan People's Center and the Municipal Building Annex has been utilized as parking area of vehicles – both by LGU clients and non-clients, causing congestion and difficulty of passage of motorists going to and from the Camaligan Parish Church;

**WHEREFORE**, on motion by Councilor Jose O. Agomaa, Jr. duly seconded by Councilor Shiela A. Morico:

**BE IT ORDAINED** by the Sangguniang Bayan of Camaligan, Camarines Sur, that:-

**SECTION 1.** Section 8, Article II of the 2008 Revised Transport and Traffic Code is now further amended to read as follows:

**SECTION 8 – Deputized Traffic Enforcers.** *The Local Chief Executive may designate/deputize traffic enforcers to support the PNP personnel in their traffic tasks. Appointment however shall be subject to the availability of funds as they shall be paid wholly out of municipal budgets. Training and supervision shall be under the Philippine National police.*

**SECTION 2.** Section 24, Article V, is now amended to read as follows:

## ARTICLE V - PARKING

**SECTION 24 –Prohibited Areas.** No operator or driver of any vehicle shall park his vehicle or permit to stand, whether attended or unattended on any street:-

- a) At the intersection or within six (6) meters from an intersection;
- b) On a crosswalk/pedestrian lanes;
- c) Within four (4) meters from a driveway entrance to any Fire and Police Station or from any fire hydrant;
- d) In front of private driveways;
- e) On the roadway of any side of any stopped or parked vehicle and/or at a curb or edge of any street;
- f) On top and on approaches of bridges; on sidewalks, drainages and public alleys;
- g) Making the street as temporary garage and/or PUJ terminal and/or; use for overnight parking.
- h) Between the Camaligan People’s Center and the Municipal Building Annex

**SECTION 3.** This ordinance shall take effect ten (10) days after its approval within which information dissemination shall have been widely conducted, including the posting of this ordinance at conspicuous places in the thirteen barangays of the municipality.
